Gift Aid Scheme

From 6 April 2008, Somerville is able to reclaim 25p for every £1 given under the Gift Aid Scheme. If you pay Income Tax at the higher rate, you must declare all your Gift Aid donations on your annual Self Assessment tax return in order to obtain the additional tax relief that is available to you. Somerville is a registered charity; its number is 1139440. Therefore gifts to Somerville are exempt from Inheritance Tax and Capital Gains Tax.
