#### Summary of progress

Groundworks to the site are progressing, with the piling matt installation continuing. Surveys are being carried out to coordinate with the new services and re-routing essential existing services. Existing foul drainage must be rerouted also.

#### Works Completed

Works which we have completed since the last report are:

- Gridlines for the build plotted out
- Hoarding to Lincoln college carpark erected
- Excavation for storm water soak away completed
- 50% of piling mat completed
- Establish site accommodation
- Identified exposed services on site

#### levels of noise and disruption

In the following weeks we will be installing a storm water tank. Our site cabins will also be installed at low level, they will be lifted onto the site at the Walton Street entrance 10/01/2018. Removal of the railings has commenced to allow us to complete this. Our hoarding line will be moving to the edge of the road on Walton Street. Unfortunately, this does mean from 15/01/2018 the pavement on this side will be closed for the next year. We will be installing a temporary pedestrian to reroute all pedestrians safely across the road. We need to relocate the gas meter serving Lincoln college accommodation unit to allow us to remove and replace the existing fire escape spiral stair.
